### POINT NO. 1:- CONFIRMATION OF MINUTES OF 34TH AGM

Minutes of the 34<sup>th</sup> Annual General Meeting of the Association was circulated alongwith the Annual Report of the Directors and the same is also placed before the each Members present in the Meeting, however, if the members wants the same to be read? Hon. Gen. Secretary inquired from the House. The Members gone through the Minutes and approved the same without any change. Therefore the Minutes of the 34<sup>th</sup> Annual General Meeting was confirmed with the unanimous approval of the House.

### POINT NO.2: - ADOPTION OF ANNUAL REPORT

### LABOUR MATTER

As all of you are aware about Supreme Court Case which the Association is fighting against the Bombay Iron & Steel Labour Board, challenging the Judgment of Bombay High Court, though the final judgment is yet to come, however temporary stay is granted.

# **QUALITY CONTROL ORDER 2007**

Now the Government have decided to implement the Quality Control Order 2007 from February 12, 2008. Therefore those Members who have yet not obtained the BIS certification are requested to apply for the same.

We have come a long way from the small beginning in 1972, now we are at the threshold of 36 years of valuable and event full service to our members in the State. We are recognized by all the Government Departments Central as well as State and therefore, we are able to represent the cause of our industry at any forum if the Members utilize the benefit of this plate-form. I therefore request all of you, if you have any problem, which Is coming in the way of smooth functioning your business activities, please bring the same to our notice, we will make all possible efforts to safeguard the interest of our Members.

#### 01.03.2008

A reminder letter was sent to Chief Engineer, MSEDCL, Konkan Zone, Kalyan, about the load shedding in Wada region, copy of this letter too was sent to Chief Engineer, MSEDCL, Prakashgad, Bandra, and Managing Directors MSEDCL.

#### 01.03.2008

A circular was sent to Members revising the rates of Brokerage on finished products.

#### 03.03.2008

Letters addressed to Chief Engineer, MSEDCL, Konkan Zone Kalyan, Chairman, MSEDCL, The Secretary, Maharashtra State Electricity Regulatory Commission(MERC) Chief Engineer, Commercial, MSEDCL, asking them not to charge A.S.C. charges as per the directive of Maharashtra State Electricity Regulatory Commission (MERC) that MSEDCL is not liable to charge ASC charges in the loading areas.

It was requested to BIS officials to request the Ministry of Steel for postponement of above Order for at-least six months for accessary preparation to the Steel Industry.

A reminder was sent to Chief Engineer, MSEDCL, Konkan Zone, Kalyan, regarding the refund of Additional Supply Charges (ASC). Similar letters were also sent to Suptd.

Engineer, MSEDCL, Vasai. Chief Enginner, Commercial.

#### 23.05.2008

Common Affairs, Common Affairs, Minister of Food, Civil Supplies & Consumer Affairs, of Maharashtra and the Divisional Commissioner Konkan regarding the indefinite teasy in renewal of solvent licences.

#### 23.05.2008

Name of Five Rerolling Mills have been forwarded by the Association to Project Management Cell, UNDP/GEF, Ministry of Steel for selection as Model Units.

#### 21.08.2008

A circular was sent to Members asking them to participate in a State Level Award for Energy conservation and Management organized by Maharashtra Energy Development Agency (MEDA).

#### 22.08.2008

A letter was addressed to Chairman, Chief Engineer, Superintending Engineer, MSEDCL on implementation of Order dated 07.02.2007 in case No. 59 of 2006, which wrongly implemented.

#### 01.09.2008

A letter was addressed to Chairman, Central Board of Excise & Customs (CBEC) regarding the difficulties faced by the Members in view of the Mandatory Tax payment through E-Payment mode, as the most of the Govt. owned banks itself are enable to do so.
