President Shri Rajendra Prasad Vaish took the chair and called the Meeting in order, as the necessary quorum was present, he asked the Hon.Gen.Secretary Shri Kamal Kishore Gupta to read the Notice dated 1.12.2010 convening the 38th Annual General Meeting. Shri Kamal Kishore Gupta welcomed the Members present at the Meeting and started the proceeding of the 38th Annual General meeting.

POINT NO.1 - CONFIRMATION OF MINUTES

Minutes of the 37th Annual General Meeting was circulated along with the Annual Report of the Board of Directors and as the same was once again placed before the each of Member of the House. The Hon.Gen.Secretary inquired from the House, if there is any correction or deletion required, since there was no query from the House. The Minutes treated as approved by the unanimous permission of the House.

- A letter was sent to Commissioner of Sales Tax, Maharashtra, requesting them to clear the confusion among the traders about the years for keeping of old records.
- Minister, Govt. of Maharashtra, Secretary, Ministry of Finance, Govt. of
 Maharashtra that after the implementation of VAT no Assessment Orders are
 issued to Assessee and therefore, they are always in doldrums whether their
 assess-ment is completed or not, and if completed what are the findings.
- Notification on revised rate of 5% Vat was circulated to Members as the same was implemented from 1st May 2011.

- 09.06.2011 In reply to our letter dated 15th April 2011 a letter was received from Additional Commissioner (VAT)3, Maharashtra Sales Tax asking us to Produce the name of Members whom no Assessment Order or no finding Report is issued after conducting of Audit.
