MINUTES OF THE 39TH ANNUAL GENERAL MEETING HELD ON DECEMBER 23, 2011 AT HOTEL PENINSULA, MUMBAI.

President Shri Hira Lal Dargar took the chair and called the Meeting in order, as the necessary quorum was present, he asked the Hon.Gen.Secretary Shri Kamal Kishore Gupta to read the Notice dated 2.12.2011 convening the 39th Annual General Meeting. Shri Kamal Kishore Gupta welcomed the Members present at the Meeting and started the proceeding of the 39th Annual General meeting.

POINT NO.1 – CONFIRMATION OF MINUTES

Minutes of the 38th Annual General Meeting was circulated along with the Annual Report of the Board of Directors and as the same was once again placed before the each Member of the House. The Hon.Gen.Secretary inquired from the House, if there is any correction or deletion required, since there was no query from the House.
