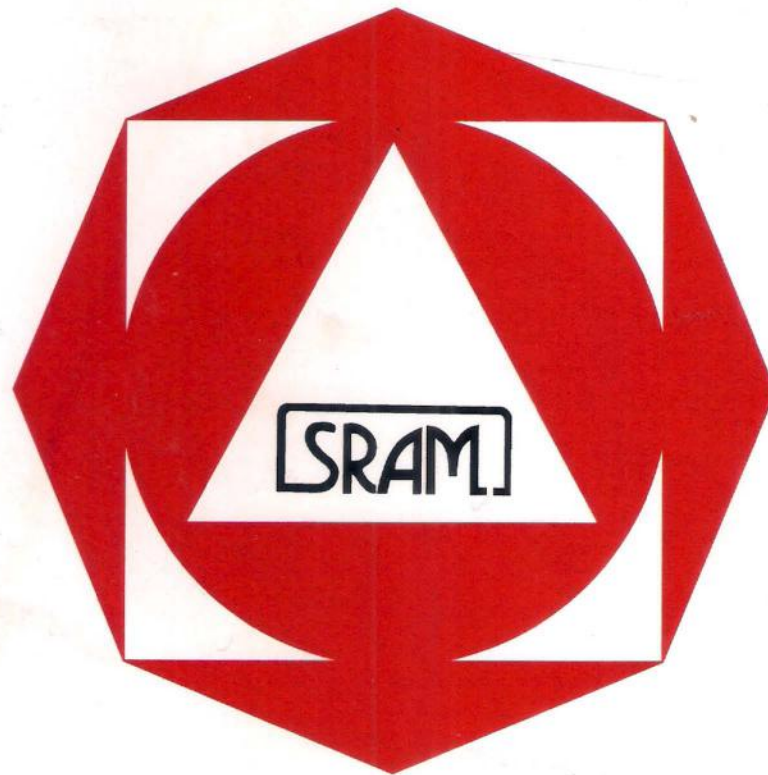

**MINUTES OF THE 42ND ANNUAL GENERAL MEETING HELD ON
DEC. 26, 2014 AT BOMBAY PRESIDENCY GOLF CLUB, MUMBAI.**

President Shri Hiralal Dargar took the chair and called the Meeting in order, as the necessary quorum was present, he asked the Hon.Gen.Secretary Shri Kamal Kishore Gupta to read the Notice dated 5.12.2014 convening the 42nd Annual General Meeting. Shri Kamal Kishore Gupta welcomed the Members present at the Meeting and started the proceeding of the 42nd Annual General meeting.

POINT NO.1 – CONFIRMATION OF MINUTES

Minutes of the 41st Annual General Meeting was circulated along with the Annual Report of the Board of Directors and as the same was once again placed before the each Member of the House. The Hon. Gen. Secretary inquired from the House, if there is any correction or deletion required, since there was no query from the House. The Minutes treated as approved by the unanimous permission of the House.

POINT NO.2 - ADOPTION OF ANNUAL REPORT TOGETHER WITH THE ACCOUNTS

As the Annual Report of the Directors alongwith the Audited Statements of Accounts was circulated to all the Members well in advance. However, the Board asked the House to see if there is any clarification explanation required by any Member of House. FROM THE PRESIDENT DESK:

Dear Members,

The Board of Directors are pleased to place before you the 43rd Annual Report of the Association. The 42nd Annual General Meeting of the Association was held on 26th December 2014, wherein I was elected as the 11th President of this Association for which I once again thanks you all. Friends, as all of you are well aware when I was reposed this responsibility the condition of Steel Industries then and now not much differ, inspite of very strong efforts of my Team of Directors nothing much achieved, only the thing which we have been able to do we brought SRAM in lime light today from Central to State we are recognized as a Premier Body of Secondary Steel Sector. During the period of this 13 months from the Prime Minister to Chief Minister we have not left any one where SRAM voice is not reached, however, unfortunately I have no hesitation to say that nothing much could be achieved except the assurances and promises from top to bottom.

In our first attempt itself we have been able to convince our Hon'ble Chief Minister Shri Devendra Phadnavis ji on our two major problems of Power tariff and dumping of finished goods from other State in lack of, no any hurdle in materials coming from the neighboring states. Fortunately our both demands were accepted by the Government, Chief Minister promised to give Rs. 1.50 discount in Power tariff and also levy entry tax on goods coming from other states. The second one Entry tax was imposed on goods coming from neighboring states, but the form in which it was imposed was not so fruitful as the full set-off is available on this, but certainly upto certain extent it reduced the quantity of goods coming from other states.

In this regard in our regular meeting with Finance Minister Shri Sudhir Mungtiwar ji we apprise him about this loophole where finance Secretary was also present and agreed to put some clause in entry tax bill like only allowing 50% setoff or put the condition that the setoff will be given only after assessment. But I surprised even though this idea of mine, was very much appreciated by the Finance Minister and Finance Secretary as it was revenue generating, even though they also promised, that the revenue generated from this will be diverted to subsidies power tariff, but why the same was not done, not known.

Friends, overall the condition of our Industry is very much worsening, from FICCI to CII IMC & MCCIA every one we apprise and known that how difficult time the Steel Industry is facing throughout the Country and I express my sincere thanks to these Chambers of Commerce and Industry , who are fully supportive to our issues to be taken

care, and as the Govt. is well aware of the condition of steel industry, are also very keen to take corrective measures, but these measures are still awaited, as far as Maharashtra is concern, it is most affected, amongst the various reasons one of the most impacting reason is the power tariff which is continuing to be highest ever in the Country, and there is no sign of any rebate to be given in that. Due to its geographical presence near port, import from China is continuous challenge for our survival, the Industry was very hope full with imposition of Minimum Import Price (MIP) , but this is also set aside.

Friends the A.G.M. this year is delayed by one and half month, due to major renovation work of SRAM office and it is a matter of proud for us that today we have a well furnished office, with all requisite facility like RJM BOARD ROOM & CONFERENCE HALL, Mini Meeting Room by Sona Alloys Pvt. Ltd, a well furnished Double Bed Guest Room Made in memory of Late Shri Puranlalji Agarwal by Sanvijay Group, Nagpur, Shri Chimanlal Aggarwal Chamber by Guardian Group. These facilities of Association office can be utilised by the Members free of cost as and when they need the same. Friends during the year under review, we have been to enroll 18 new Members , 15 ordinary and 3 Associates. Friends, I feel proud

to be the President of SRAM, which has come a long way from the small beginning in 1972, now we are at the threshold of 43 years of valuable and event full services to our Members in the State. It is also a matter of proud for us that todays President of India Shri Pranab Mukherji was one time Chief Guest in our Joint General Meeting with AISRA. as then Finance Minister.

Friends your Association is recongnised by all the Government Departments, central as well as state and therefore, I request you all to please come forward and utilize this Plate-form, unitedly we can fight more strongly, instead of individually. So I request all of you to please bring more and more Members into the folds SRAM.

Now I will conclude my address, I express my sincere thanks to my Team of Board of Directors, Members of Advisory Board , sub-committees and Members for their active co-operation, suggestion and support which enable me discharge my duty so ably.

The Board also appreciate the prompt and efficient services rendered by the Secretary and the Staff of the Association, without whom, it would not have been possible to carry out day to day activities of the Association so efficiently.
